**INSTRUCTIONS TO BIDDERS**

The following information in subject Request for Proposal is changed as follows:

1. **Section I, Item C:** Delete this item.
2. **Section I, Item D:** The location where changes, additions, and modifications to the bid request will be posted is changed to the Fairfield City Schools web site at [www.fairfieldcityschools.com](http://www.fairfieldcityschools.com).
3. **Section I, Item E:** Clarification. The bid opening date should read January 7, 2010 at 3:00 P.M. (Central Time).
4. **Section II, Item A**
  - a. **Paragraph (2):**
    - i. Change the number of cellular telephone lines the system expects to start service for identified in the first sentence to 16 (+/-).
    - ii. Delete the last sentence (highlighted).
  - b. **Add Paragraph (6):** "Pricing is also requested for cellular data cards (Aircards) and service plans (not currently eligible for E-rate funding). Fairfield City School District expects to start service for a total of approximately 1 card. The quantity of cellular data cards will change based on the district's needs, with on additional costs beyond those quoted."
5. **Section IV, Item A):** Change the number of Bid Response Form pages to 13.
6. **Bid Response Form (all pages):**
  - a. Change the total number of Bid Response Form pages identified on the top of each page (pages 13 through 20) to 13 (vice 12).
  - b. Insert/add the attached Bid Response Form (Page 13 of 13) containing the Cellular Data Cards (Aircards) proposal sheet to the RFP and Bid Response Form.
